MEMORANDUM OF UNDERSTANDING

BETWEEN

**FACULTY OF HEALTH STUDIES, SARAJEVO UNIVERSITY / FAKULTET ZDRAVSTVENIH
STUDIJA, UNIVERZITET U SARAJEVU**

AND

**ANGELA BOŠKIN FACULTY OF HEALTH CARE / FAKULTETA ZA ZDRAVSTVO ANGELE
BOŠKIN**

Faculty of health studies, Sarajevo university, and Angela Boškin faculty of health care (ABFHC) wishing to establish cooperative relations, and express willingness to collaborate as follows.

AREA OF COLLABORATION

Subject to approval of Faculty of health studies, Sarajevo university, and Angela Boškin faculty of health care, collaboration will be undertaken through mutual activities within health studies study programs:

1. Exchange of faculty members
2. Exchange of initiatives, information and experience in the field of education and scientific research
3. Joint research and development activities
4. Exchange of academic materials
5. Realization of other activities for which the parties have a common interest.

TERMS OF AGREEMENT

All terms and budgets for activities implemented under this agreement shall be mutually agreed upon in writing prior to its initiation. Activities must be approved individually by authorized individuals from each party.

Each participant shall designate a liaison officer to facilitate timely and accurate communications between the parties.

For the purposes of this Memorandum of Understanding («Agreement») and all further communications related to each specific activities between the Faculty of health studies, Sarajevo university, and Angela Boškin faculty of health care, it is understood and agreed that neither party

shall be liable for any negligent or wrongful acts, either of commission or omission, chargeable to the other, unless such liability is imposed by law. This agreement and all eventual addendas shall not be construed as seeking to either enlarge or diminish any obligation or duty owed by one party to the other or to a third party.

RENEWAL, TERMINATION AND AMENDMENT

This agreement shall remain in force for a period of three (3) years from the date of the last signature, with the understanding that it may be terminated by either party giving sixty (60) days written notice to the partner institution.

This agreement may be amended with the consent of the two institutions through a written addendum executed by authorized individuals of both institutions. Such addenda, once approved by both institutions, will become part of this memorandum of agreement.

This agreement shall be binding upon signing by authorized individuals of both institutions and shall be effective as of the date last written below.
